Location

XSITE is located next door to Braehead Shopping Centre and Retail Park, **Dobbies**, **IKEA** and **Decathlon**. It is just 5 miles to the west of Glasgow which is ranked number 2 in CACI's Great British Centres on an annual comparison spend. The internal unit is prominently positioned on the upper level between a 12 screen **Odeon Cinema** and **Snow Factor** (Scotland's only indoor ski slope).

The leisure scheme benefits from a wealth of other recognised operators including **Nando's**, **Five Guys**, **Frankie & Benny's**, **TGI Fridays**, **Harvester**, **Pizza Express**, **Gravity**, an 18 indoor hole **Paradise Island Adventure Golf**, a 22 lane **Tenpin** bowling centre, **JD Wetherspoons**, **Fun Station** and various other bars and restaurants.


