Location

XSITE is located next door to Braehead Shopping Centre and Retail Park, **Dobbies**, **IKEA** and **Decathlon**. It is just 5 miles to the west of Glasgow which is ranked number 2 in CACI's Great British Centres on an annual comparison spend. The internal unit is prominently positioned on the upper level between **Fun Station** and **Snow Factor** (Scotland's only indoor ski slope).

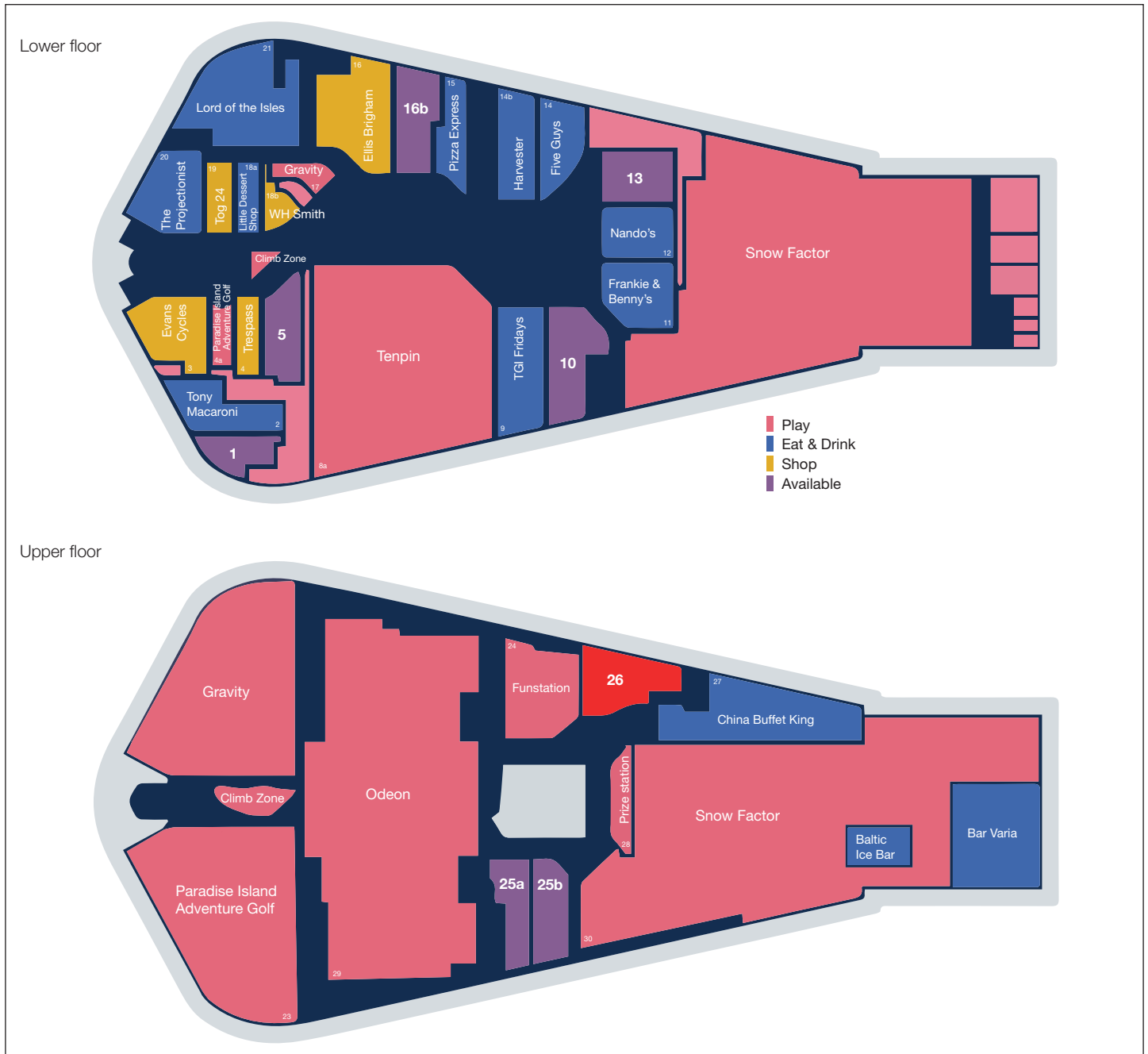
